The first joint auction held after the Chinese New Year resulted in an exceptional performance.

The total amount made from the final bid reached around NTD 55,470,000 .

The first joint auction held after the Chinese New Year on fourth of Feb. by the branches of AEA provided various items and attracted the public to bid. The total amount realized from the final bids of real properties and personal properties reached NTD 55,477,992. The performance of the auction ended with an exceptional result.

The auction of real properties mainly included the lands located in New Taipei City, such as those located in Banqiao District, Yingge District and Wugu District, etc. and auctioned by the New Taipei Branch. The total amount of the final bid is around NTD 37,650,000. The lands were located in Taoyuan City, such as those located in Taoyuan District, Fuxing District and Luzhu District, etc. and auctioned by the Taoyuan Branch. The total amount of the final bid is around NTD 3,580,000. The lands were located in Central District of Taichung City and auctioned by the Taichung Branch. The total amount of the final bid is NTD 5,000,000. The lands were located in Minhsiung Township of Chiayi County and auctioned by the Chiayi

Branch. The total amount of the final bid is around NTD 4,140,000. The lands and buildings were located in Yilan City of Yilan County, Shuangxi District and Wanli District of New Taipei City and Zhongzheng District of Keelung City and auctioned by Yilan Branch. The total amount of the final bid is around NTD 3,760,000.

The auction of real properties ended with exceptional results. The total amount made from the final bid is NTD 54,266,742.

In addition, the total amount made from the final bids of personal properties auctioned by the branches is NTD 1,211,250.

The personal properties included items such as sunglasses, cloth, scarves, belts, gloves, bridal headpieces, earrings, brooches, necklaces, bracelets, rings, socks, wallets, leggings, shoes, sportswear, nail stickers, fans, water bottle bags, etc. auctioned by the Taipei Branch. The total amount of the final bid is around NTD 120,000. One Mercedes-Benz vehicle, bags, jewelry, women's clothes, tea cups, etc. auctioned by the Shilin Branch. The total amount of the final bid is around NTD 720,000. One vehicle, hand cream, deodorant, goggles, wardrobes, mattresses, electric fans, imitation bronze

decoration and liquor, etc. auctioned by the Taoyuan Branch. The total amount of the final bid is around NTD 290,000. There were also auctions of several personal properties in other branches. Not only did the people happily take advantage of the cheap stuff, but also the treasury recovered a huge amount of taxes and fees to create good results.

During the epidemic of the COVID-2019, we are glad that the public is willing to cooperate with the measures implemented by the AEA, such as taking temperature and wearing masks. The joint auction held on the "first" "Tuesday" of every month, starting at "3"
