## **Warmness on Dragon Boat Festival**

The Director-General of AEA, Lin Ching-Tsung, the Director of Kaohsiung Branch, Yeh Tzu-Chiang, members of the Caring club of the Branch and members of Huashan Social Welfare Foundation jointly visited the solitary elderly residents (June 20), and provided consolation payment and Dragon Boat Festival gifts to them. The residents could feel the warmness and caring from AEA.

An elder woman who couldn't stand straight due to lordosis, and had difficulty with actions caused by degenerative joint disease, could only rely on crutches to move. Therefore, she doesn't have a job or any income and has been suffering from poverty. Her husband had passed away many years ago. With the solitary living environment in a tiny tin house, the recent heat and hot weather make her life even worse.

Once the Director-General, Lin, who continually cared for the disadvantaged, realized the situation during his visit to Kaohsiung Branch. He decided to visit the elder woman with the Director of Kaohsiung Branch before the Dragon Boat Festival, to give her the consolation payment and Dragon Boat Festival gifts, and to take practical actions to encourage her with the caring and kindness of the executive system to on Dragon Boat Festival as happy as possible.

AEA always provides multiple services to the public with the core value of justice and caring. In addition to disgorging the person who owed a huge amount of penalty actively to achieve the creditors' rights of the government and implement the public law authority, AEA also provides multiple measures, such as installment payments, referrals to social welfare authorities, or notify relevant local government agencies etc. to those obligors who are in financial difficulties. On the other hand, the branch offices follow the guidance of AEA, and hold or participate many charity events actively, such as jointly visiting the solitary elders by the Kaohsiung Branch and Huashan Social Welfare Foundation, caring for the obligor blind in one eye by the Taichung branch, donations to stroke elders in the same household by the Chiayi branch, donations to a single mom with a child with dissociation by the Tainan branch, bringing warmness to remote villages by the Yilan branch, funding Juvenile Home by the Hualien branch, giving daily goods during Chinese New Year by the Taoyuan branch, donating daily goods to the

nursery by the Changhua branch, promoting donations of goods in a charity event by the Pingtung branch, providing clearing service for elders by the Hsinchu branch, holding charity bazaar and donating the amount made by the Taipei branch, donations to a single mom with six children by the New Taipei branch and blood donating event held by the Shilin branch, etc. These caring measures show the care and assistance provided to the disadvantaged continually by the executive system. In order to implement the ideas of "justice and caring," AEA and all the branches will continue to embrace these core value to help the disadvantaged actively while implementing the public authority.
