## **The joint auction on the “first” “Tuesday” of every month, starting at “3” p.m.” made NTD 156,560,000 for the Administrative Enforcement Agency!**

In order to follow the instructions of Epidemic New Life and maintain the public health simultaneously, the joint auction held on the “first” “Tuesday” of every month, starting at “3” p.m.” on September 1 by the branches of AEA started to arrange the on-site auctions of real property and personal property gradually, and all the venues provided for the on-site auctions were in compliance with the epidemic prevention instructions provided by the CDC.

Except for Changhua Branch, and Chiayi Branch suspended the auction of personal properties, all the other branches held on-site auction for the personal properties; Except for the New Taipei Branch, Hsinchiu Branch, Tainan Branch and Pingtung which only allowed communications bidding, all the other 9 branches adopted the communication bidding and on-site bidding for the auction of real properties.

The total amount made from this conclusion of the auction reached NTD 156,566,787, which is an exceptional result.

The total amount made from the highest-bidding of the real

property is NTD 148,442,941. The one with the highest bid is a B&B located in Dongshan Township, Yilan County and auctioned by Yilan Branch. The amount made from the highest-bidding is NTD 37,510,000; The one with the second-highest bid is the land and building (including a parking space) located at Xiyuan Rd., Xindian Dist., New Taipei City and auctioned by Taipei Branch. The amount made from the highest-bidding is NTD 19,300,000.

Other real properties provided for this auction include a first-floor store located at a building on Chenggong Rd., Sanchong Dist., New Taipei City, and auctioned by the New Taipei Branch. The amount made from the highest-bidding is NTD 10,311,000. This case is auctioned by “Communication Bidding”; The land and building located at Hefeng Second Section, Xindian Dist., New Taipei City, and auctioned by the Taipei Branch. The amount made from the highest-bidding is NTD 9,588,000. Other branches also auctioned a few qualified real properties and had excellent results as well.

There are 11 branches holding auctions for personal properties today. The total amount made from the highest-bidding was NTD 8,123,846.

The one with the highest bid is 7 Fuso Truck-bus from 2007 to 2016 auctioned by the Kaohsiung Branch. The amount made from the highest-bidding is NTD 6,100,000.

The one with the second-highest bid is a 2016 purple MASERATI sports car entrusted by Taoyuan Prosecution Office and auctioned by Taoyuan Branch. The amount made from the highest-bidding is NTD 1,830,000.

Other personal properties auctioned this time also include a HINO truck, jade ornament, pearl earrings, stocks, cakes, roasted ducks, LED television, ASUS personal computer, pet supplies, etc.
