Great Start to Lantern Festival

The total highest-bidding amount made from the AEA joint auction held on the "first" "Tuesday" of every month, starting at "3" p.m. exceeds NTD 140,810,000.

Today, February 15, 2022 is the Lantern Festival, all branches of AEA hold the first joint auction held on the "first" "Tuesday" of every month, starting at "3" p.m. after Lunar New Year. All branches provide various items for the public to bid on. The total amount made from the highest-bidding of the joint auctions reached NTD 140,819,972, and all income thereof will be collected by the treasury.

The total amount made from the highest-bidding of the auction of real properties was NTD 132,788,465. The one with the highest-bidding amount is the auction of 6 staff dormitories of Prince Motor Co., Ltd., which is at Section 5, Chongxin Road and near Xianse Temple Station in Sanchong District, and auctioned by New Taipei Branch. The amount made from its highest-bidding is NTD 35,460,000; in addition, a first-floor store located at Sanmin Road, Luzhou District, was auctioned for NTD 12,449,000. There is also a land located at Gangpin Subsection, Chiayi City and auctioned by Chiayi Branch. The total amount made from its highest-bidding is NTD 24,280,000. In addition, a house located in Beitun District, Taichung City was auctioned by Taichung Branch. The total amount made from the highest-bidding is NTD 14,686,666; and there are also three land located in Daya District, Taichung City and auctioned by Taichung Branch. The total amount made from the highest-bidding is NTD 14,000,000. There are two lands located at Xinxing Section, Tainan City was auctioned by Tainan Branch. The total amount made from the highest-bidding is NTD 14,000,000.

those is NTD4,705,459. A building located in Renwu District, Kaohsiung City and auctioned by Kaohsiung Branch for NTD 1,660,000. Other branches also auctioned various real properties in good conditions and ended the conclusion of the auction with exceptional results.

The total amount made from the highest-bidding of movable properties was NTD 8,031,507. The most eye-catching and highest-bidding item was a 2021 Mercedes-Benz sedan entrusted by Taichung District Prosecutor's Office and auctioned by Taichung Branch for NTD 3,425,000. There are also a 2015 BMW sedan auctioned by Taichung Branch for NTD445,000, a 2010 truck from CHINA-MOTOR auctioned by Taichung Branch for NTD \$475,000, and a forklift auctioned by Taichung Branch for NTD 600,000. In addition, a 2016 sedan from Kuozui Motors, Ltd. is auctioned by Taoyuan Branch for NTD 300,000; a 2011 sedan from Luxgen Motor Co., Ltd. is auctioned by Chiayi Branch for NT\$100,000. Other movable properties auctioned or sold in this joint auction include watercolor paintings by Cheng Hsiang-Long, laser machine from Tansan Gas, Hermes belts, handmade Poland pottery, gloves, headphones, wide-angle lenses, engineering block gift sets, educational toys of Romance of the Three Kingdoms, puzzles, Kitty toys with sound and light effect, furniture made by logs, stocks and etc.

AEA reminds the public that although the epidemic has slowed down, the epidemic prevention measures implemented by CECC should still be followed, such as real name registration at various venues, keeping social distances, measuring body temperature, and seeking medical care and refraining from entering the auction venues when having fever to avoid creating any breach on the epidemic prevention measures.
