are, provided in the auction**

**The total highest-bidding amount made from the AEA joint auction held on the “first”
“Tuesday” of every month, starting at “3” p.m. reaches around NTD 170,530,000.**

On August 2, 2022, the AEA joint auction held on the “first” “Tuesday” of every month, starting at “3” p.m. was held by all branches of AEA. The branches offer rare supercars, Oriental Jasper carvings and a variety of auction items for the public to purchase in the auction. The total amount made from the highest-bidding of the auction reached NTD 170,531,410, and the income of the auction will be provided for the treasury.

The total amount made from the highest-bidding of the real properties is NTD 133,120,284. The one with the highest-bidding amount is the building located in Section 2 of Guangming Road, Luzhu District, Taoyuan City, and auctioned by Taoyuan Branch with the entrustment of Taiwan Miaoli District Prosecutors Office from the “Hung-Fu-Hai” cases for NTD 17,350,000. Those with the second highest-bidding amount are 15 suites of a hot spring hotel located in Zhiben District, Taitung County and auctioned by Hualien Branch for NTD 9,574,816; and two lands located at Caofen Section, Ji’an Township and auctioned by Hualien Branch for NTD 7,907,585. In addition, there is a parcel of land located at Tuku Section, West District, Taichung City and auctioned by Taichung Branch for NTD 8,689,999; and there is also a building located at Luchuan West Street, Central District, Taichung City and auctioned by Taichung Branch for NTD 8,500,000. In addition, there is also a building located in You’ai Street, West Central District, Tainan City, near Confucius Temple

auctioned by Tainan Branch for NTD 5,352,000; and there is also a land located in the Xuezhong Section, Annan District, Tainan City and auctioned by Tainan Branch for NTD 4,667,300. There is land and two buildings located at Zhuzijiao section, Fengshan District, Kaohsiung City and auctioned by Kaohsiung Branch for NTD 4,989,999; there is also a land located at Gangshan Section, Gangshan District, Kaohsiung City and auctioned by Kaohsiung Branch for NTD 2,100,000. There is land located at Donghu Section, Minxiong Township, Chiayi County and auctioned by Chiayi Branch for NTD 1,390,000. Other branches also auctioned various real properties in good locations and ended the conclusion of the auction with exceptional results.

The total amount made from the highest-bidding of personal properties in this auction is NTD 37,411,126. The most eye-catching item with the highest amount made from the highest-bidding are of 67 pieces of carved artworks made by Oriental Jasper and Qingtian stones, which are auctioned by Hsinchu Branch with the entrustment of Taiwan Miaoli District Prosecutors Office from the “Hung-Fu-Hai” cases. An appreciation event is held and many experts and scholars are invited to introduce the items, and attracts a large number of connoisseurs to participate in the auction. The total amount made from their highest-bidding is NTD 27,605,000. The one with the second highest-bidding is a white Porsche SUV, which is auctioned by Shilin Branch for NTD 2,360,000 with the entrustment of Taipei District Prosecutors Office. There are also many other vehicles auctioned for good price, including automobiles from Mercedes-Benz, Tesla, Nissan Motor, China Motor, Suzuki, sedans from Kuozui Motors, trucks from Ford Lio Ho Motor and China Motor, minivan from China Motor and Nissan Motor, heavy motorcycle from Kwang Yang Motor, scooters from Motive Power and bicycles etc. The rest of the personal properties auctioned or sold include fighting robots, sandwich machines, cameras, furniture made with logs, warm gloves with e-touch function, Moët champagne, L'OCCITANE diffuser, Blue-tooth speaker, Kinmen Kaoliang Liquor, Pu-Erh tea, crystal germanium pendant, Swarovski crystal germanium bracelet, jasper ornaments, jasper cabbage ornaments, T-shirts, polo shirts, basketballs, stocks and other items.

AEA reminds the public that the local epidemic of COVID-19 is still ongoing, the public can make use of the communication bidding to participate in real estate auctions and avoid the risk of epidemic; the public who participate in the on-site bidding of personal properties at each branch should strictly comply with all epidemic prevention regulations, wear masks throughout the process, and take proper personal epidemic prevention measures to protect the health of the citizens.
