A Fruitful Results of NT\$24.53 Million from the Joint Auctions Despite the Advent of the Typhoon

All branches of Administrative Enforcement Agency, MOJ held the joint auctions held on the "first" "Tuesday" of every month, starting at "3" p.m. On August 1, 2023 during the summer vacation. Each and all branches of AEA spared no efforts to demonstrate to the general public all kinds of stuff for the auction. Even though Typhoon Khanun was approaching and there was wind and rain in various regions of Taiwan, the enthusiasm of the people still prevailed and the total bid amount reached NT\$24,533,690.

The total bid amount of real properties reached NT\$22,896,325. Among them, the one with the highest bid amount is the 5 suites of "YI-HSUAN HOTEL" auctioned by the Hualien Branch, in which the "360-degree panoramic photos" and the branch-wide first-ever "drone aerial photography" are available for each suite, allowing the bidders to view the auctioned items from multiple perspectives. It was the third bid for these suites, and the final bid amount reached NT\$5,296,385. The auctioned stuff with the second highest bid amount was the building and its base located at Xinyi Street, Tuku Township, Yunlin County auctioned by the Chiayi Branch, which was its third auction, and the final bid amount reached NT\$4.52 million. Furthermore, the Yilan Branch recently held the "Take You to Visit the Auctioned Houses" activity for vacant houses in Qidu District, Keelung City, which was well-received. On the day of the second auction, 6 groups of bidders were joined the bidding, and the final bid amount reached NT\$4,255,000, which was 22% higher than the upset price of NT\$3.48 million. Other branches have also sold several high-quality real properties.

The total bid amount for properties reached NT\$1,637,365, of which the highest and most eye-catching bid was the CMC heavy truck (2011) auctioned by the Taoyuan Branch. It was its second auction and the final bid amount reached NT\$645,000. In addition, the Shilin Branch successfully sold 3,826 shares of Sunny Bank stocks at NT\$42,345, which was higher than the market price on the very date of the auction. The Kaohsiung Branch also sold 2 cars and 5 motorcycles with a total final bid amount of NT\$333,900. Other properties for the auctions included BMW cars, motorcycles, physical stock certificates, pearl ornaments, Puer tea, hats, money clips, fax machines, trademark rights, geodes, yacht models, computer hosts, monitor lenses, sunglasses, rice, hair care products, Melaleuca (Tea Tree) oil, handmade soaps and many other good stuffs.
